
# **Policy Statement**

# Palletways focus areas for Sustainability

All the following initiatives are group wide, however there are multiple individual network initiatives, and the objective should be to push these out to the group, especially with regard to the ISO Standards 14064 greenhouse gas (GHG) verification, 14001 environmental management system and 26000 Guidance on social responsibility.

#### Decarbonisation

Reduction of Emissions, Net Carbon Footprint Project, permanent traffic optimisation.

Examples include LED lighting for hubs, returnable and reusable products, waste separation, reduction and recycling, and in best case certification of ISO 14001.

#### Social

Examples includes mental health first aid training, physical health initiatives, Health&Safety standards, principals of Investors in People, and in best case certification of ISO 26000.
